HAZARDOUS FUMES!

- DO NOT PERMIT CHILDREN TO OPERATE THIS EQUIPMENT!



Pentair always recommends 1:1 dilution when using full strength muriatic acid. When mixing, remember to always add acid to water. When adding any chemical to the pool/spa, be sure to follow the manufacturer's instructions thoroughly.



DO NOT MIX SODIUM HYPOCHLORITE AND MURATIC ACID.



Working with muriatic acid can be dangerous. Always wear rubber gloves and eye protection. When mixing, remember to always add acid to water. DO NOT add water to acid. Always work in a well-ventilated area. Splashing or spilling acid can cause severe personal injury and/or property damage. Pentair always recommends 1:1 dilution when using full strength muriatic acid. **IMPORTANT! TAKE EXTREME CARE WHEN POURING ACID INTO THE CANISTER.**
